By-law 282-90 - being a by-law to repeal By-law 107-84

The Council of the Town of Markham at its meeting held on November 27th, 1990 passed By-law 282-90 being a by-law to repeal By-law 107-84. By-law 107-84 designated the Pingle House as having historic and/or architectural value or interest pursuant to the Ontario Heritage Act. By-law 282-90 was passed because the Pingle House has been relocated to the Markham Heritage Subdivision (Lot 17, Plan 65M-2761). The Pingle House will be redesignated by Council in due course as a property having historic and or architectural value or interest.

THE CORPORATION OF THE TOWN OF MARKHAM

BY-LAW NO. 282-90

A by-law to repeal By-law 107-84. (By-law 107-84 designated the Pingle House as having Historic and/or Architectural value or interest)

WHEREAS Council at its meeting held on April 10th, 1984 passed By-law 107-84 being a by-law to designate the Pingle House as a certain property having historic and/or architectural value or interest, located on part of Lot 16, Concession 6 at the north west corner of 16th Avenue and McCowan Road;

AND WHEREAS the Pingle House has been relocated to the Markham Heritage Subdivision north side of Sixteenth Avenue and west of Highway 48 being Lot 17 on Registered Plan 65M-2761;

AND WHEREAS a new by-law will be enacted to redesignate the Pingle House at its new location being Lot 17, Plan 65M-2761 as being a property having historic and/or architectural value or interest;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF MARKHAM HEREBY ENACTS AS FOLLOWS:

That By-law 107-84 be and is hereby repealed. 1.

READ A FIRST AND SECOND TIME THIS 27TH DAY OF NOVEMBER, 1990. READ A THIRD AND FINAL TIME THIS 27TH DAY OF NOVEMBER, 1990.
