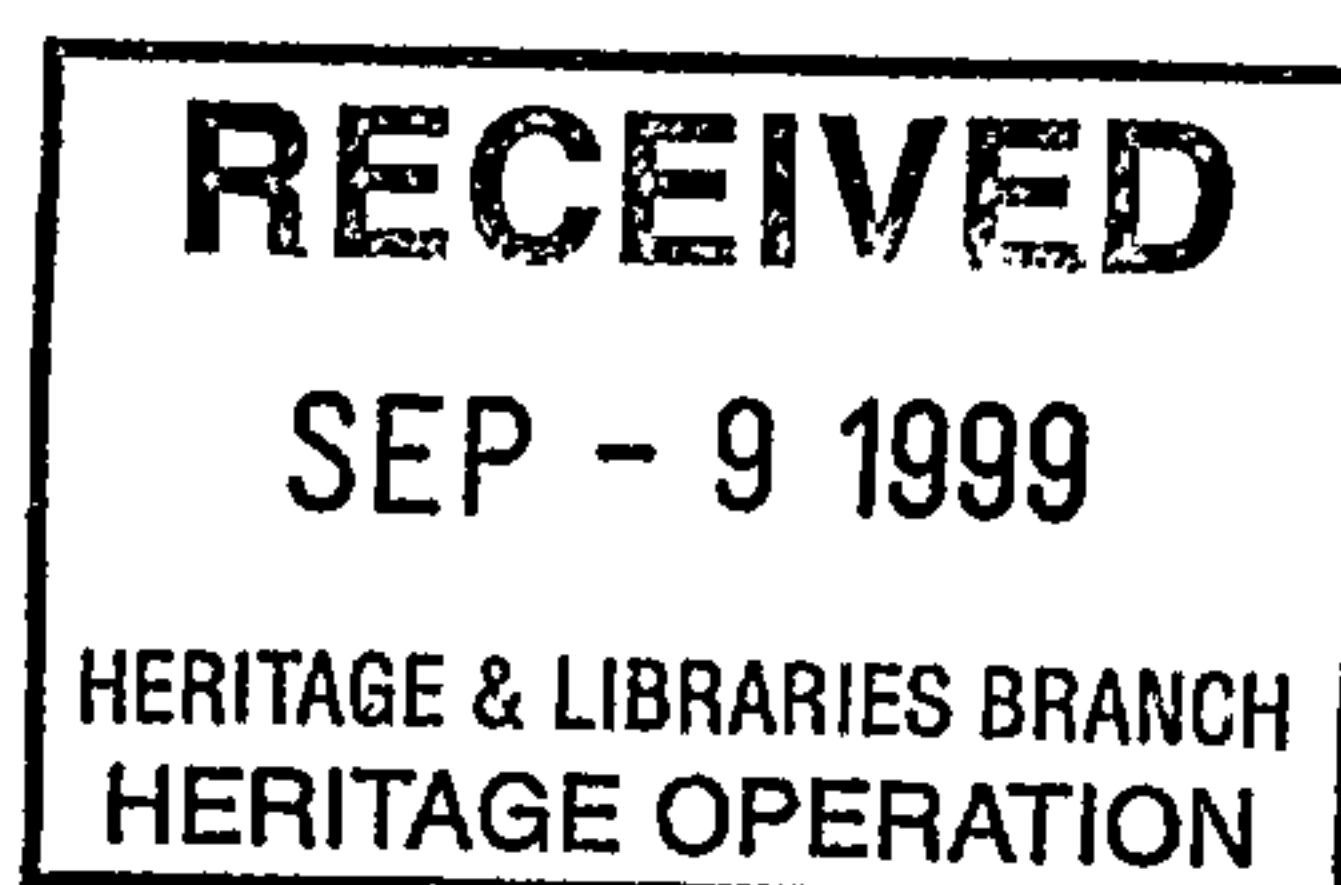

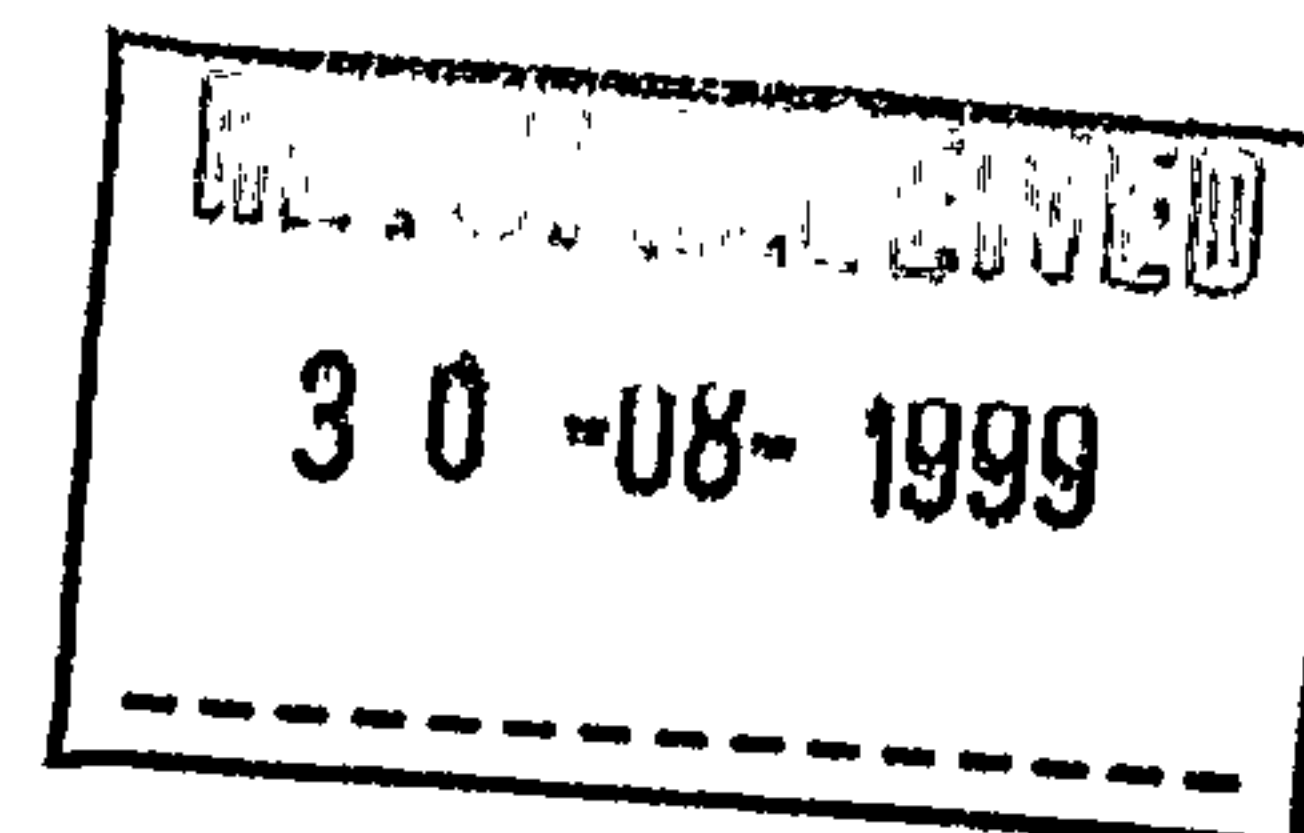

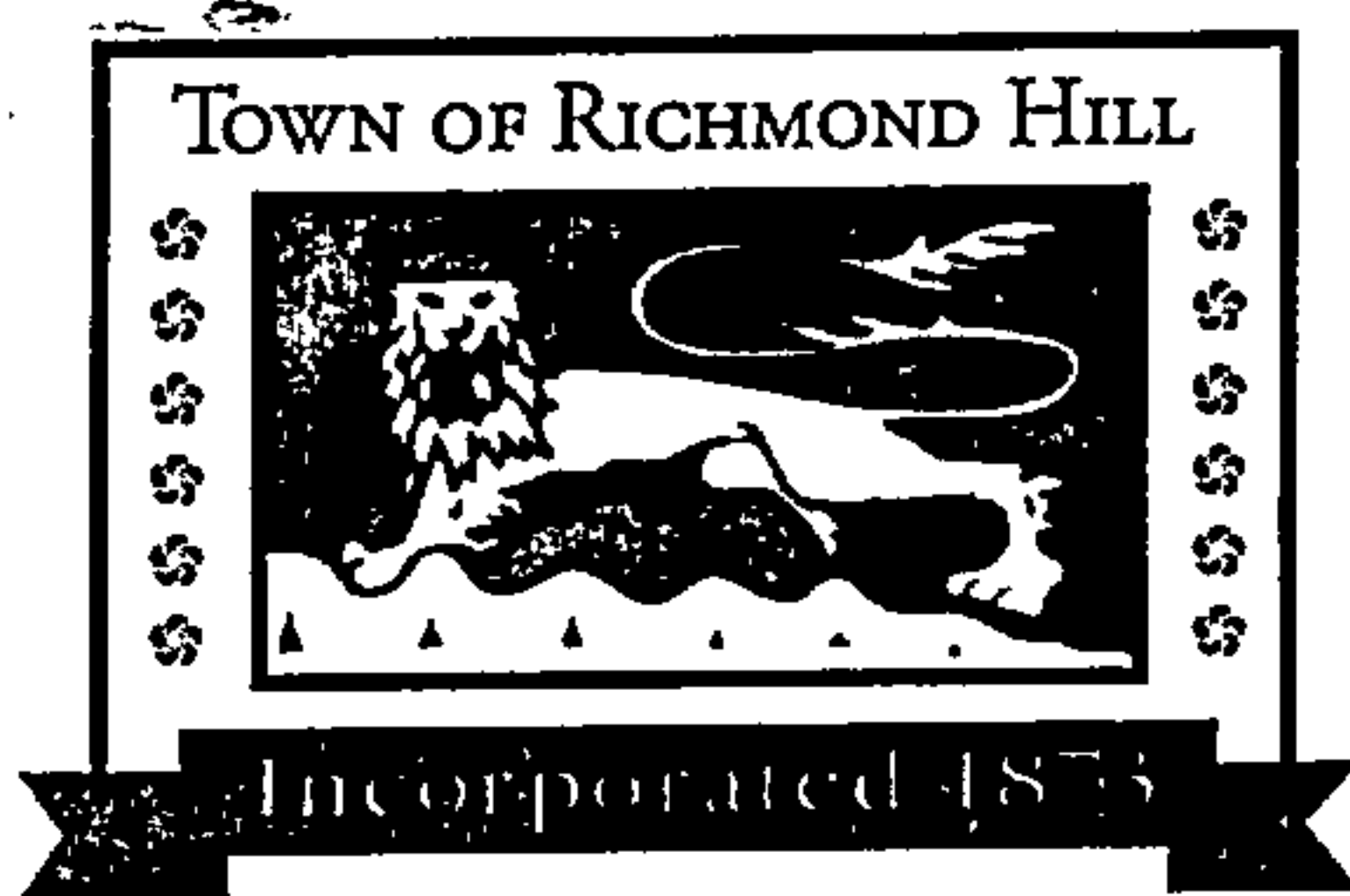

TOWN OF RICHMOND HILL ACT, 1998

Notice of Council Decision
under Section 2 (Application
to demolish designated structure)

TAKE NOTICE THAT at its meeting on July 19, 1999, the Council of the Town of Richmond Hill approved an application by Yonge Bayview Holdings Inc. for a demolition permit, to be effective on December 1, 1999, in respect of the water tower, being a designated structure under the Ontario Heritage Act, located at the southwest corner of High Tech Road and Silver Linden Drive.

Council further resolved that prior to the issuance of the demolition permit, Yonge Bayview Holdings Inc. is to contribute an amount to the Town of Richmond Hill (being \$10,000.00), to be used by the Town for the purpose of commemorating the history of the former Langstaff Jail Farm lands (bounded by Highway No. 7 on the south, Yonge Street on the west, Bayview Avenue on the east and the German Mills Creek on the north) and its historical structures in consultation with the Local Architectural Conservation Advisory Committee.

Council's decision on the application is final.

This notice is given in accordance with the provisions of Sections 2 and 7(3) of the Town of Richmond Hill Act, 1998.
