BY-LAW NUMBER **585-93**

A by-law to repeal By-law 453-93, being a by-law to designate the real property including all the buildings and structures thereon located at 37 and 39 Hurontario Street (St. Lawrence Starch Limited), as being of historical, architectural and contextual significance

WHEREAS the Council of The Corporation of the City of Mississauga enacted By-law No. 453-93 on the 15th day of September, 1993, designating the real property including all the buildings and structures thereon located at 37 and 39 Hurontario Street (St. Lawrence Starch Limited), as being of historical, architectural and contextual significance under Part IV of the Ontario Heritage Act, R.S.O. 1990, Chapter 0.18;

AND WHEREAS the lands being the subject matter of By-law No. 445-93 are more properly described in Schedule 'A' attached hereto;

AND WHEREAS the Local Architectural Conservation Advisory Committee received an application to demolish the aforesaid premises;

AND WHEREAS in accordance with the provisions of the Ontario Heritage Act, R.S.O. 1990, Chapter 0.18, the application to demolish the aforesaid premises has been considered and an agreement has been reached by the property owner and the City of Mississauga;

NOW THEREFORE the Council of The Corporation of the City of Mississauga ENACTS as follows:

1. That By-law No. 453-93, a by-law to designate the real property including all the buildings and structures thereon located at 37 and 39 Hurontario Street (St. Lawrence Starch Limited), as being of historical, architectural and contextual significance, is hereby repealed.
2. That the City Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and upon the Ontario Heritage Foundation, and to cause notice of this by-law to be published in a newspaper having general circulation in the City of Mississauga;
3. That the City Solicitor is hereby directed to register a copy of this by-law against the subject property.

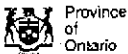
Description: Part of Lot "A", Credit Indian Reserve
