**BY-LAW NUMBER 29-18**

- of -

**THE CORPORATION OF THE COUNTY OF BRANT**

To designate a property known municipally as 24 Barker Street, Paris, under Part IV of the Ontario Heritage Act

**WHEREAS** a request was received from Dominic Zavarella on behalf of Paris Land Development Ltd., the owner of the land known municipally as 24 Barker Street, to designate the site under Part IV of the Ontario Heritage Act;

**AND WHEREAS** the Ontario Heritage Act empowers a Council of a municipality to pass by-laws to designate properties of Historical or Architectural interest under Part IV of the Ontario Heritage Act;

**AND WHEREAS** the Notice of Intention to Designate 24 Barker St. was served on the Owner of the property, the Ontario Heritage Trust, and was published in the Brantford Expositor as required by the Ontario Heritage Act;

**AND WHEREAS** the reasons for designation are attached as Schedule A to the by-law;

**AND WHEREAS** no objection to the notice for designation has been received by the Clerk of the municipality;

**NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE COUNTY OF BRANT HEREBY ENACTS** as follows:

1. **THAT** the property described as Part of the Miscellaneous Gore fronting Lots 31 & 32, geographic Township of South Dumfries, & Part Lot 9, Block 33, Plan 492, designated as Parts 1 & 2 Plan 2R-6627 and Part 2, 2R-8129, and Part of Barker Street, Plan 492, Closed by by-law registered as BC321124, designated as Part 1, 2R-8129, County of Brant, being all of PINs, 32024-0773, 32024-0771 and 32024-0699 be designated under Part IV of the Ontario Heritage Act as a property of historical and architectural significance as described in Schedule A attached to this by-law;
2. **THAT** a copy of this by-law, together with its schedules, be registered against the title of the lands in the Land Registry Office for the County of Brant;
3. **THAT** a copy of the by-law, together with its schedules, be served to the owner of the land and Ontario Heritage Trust and a notice be published of the passing of this by-law in the Brantford Expositor.

**READ** a first and second time, this 27<sup>th</sup> day of March, 2018.

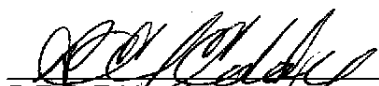
