## NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the City of Niagara Falls intends to designate the land and building known as:

### 2358 Portage Road, Halfway House Small Stone Building

as a property of cultural heritage value and interest under Part IV of the Ontario Heritage Act, R.S.O. 1990, c. O.18, as amended.

The property is located on the south side of Portage Road, near the intersection with Stanley Avenue and described as: Part 1, on Reference Plan 59R-16232, City of Niagara Falls, Regional Municipality of Niagara.

#### **CULTURAL HERITAGE VALUE**

The small stone building was built in the late 19th century and may have been used as a dairy barn as well as other uses over the years. This site has been called the 'halfway' referring to the halfway point where horses used in a horse drawn railway which went from Queenston to Chippawa were exchanged for fresh horses to continue the journey to Chippawa.

#### HERITAGE ATTRIBUTES

Key features that embody the heritage value and are important to the preservation of the small stone building at 2358 Portage Road include the following heritage attributes:

- Single storey stone building set slightly into the ground
- Stone laid in random rubble coursing
- Low pitched, gable roof
- Single window on either side of building
- Doorway opening on north end of building
- Limestone lintels
- Prominent setting on corner of Portage Rd and Stanley Ave
- Association with the 'halfway' point in the early Erie and Ontario Railway.

Notice of objection to the designation of the above noted property may be served on the City Clerk within 30 days after the date of this notice. The deadline for appeal is September 16, 2018.
