**CITY OF CAMBRIDGE**

OF THE

CORPORATION OF THE CITY OF CAMBRIDGE

Being a by-law of the Corporation of the City of Cambridge to repeal By-law 93 – 98 and By-law 206 – 98, being by-laws to designate the former exterior of the brick Queen Anne building on the property municipally known as 300 Maple Grove Road for its architectural significance.

**WHEREAS** the Ontario Heritage Act, R.S.O. 1990, Chapter O.18 authorizes the Council of a municipality to enact by-laws to designate real property including all buildings and structures thereon, to be of architectural and historic value or interest.

**AND WHEREAS** Cambridge City Council at its meeting of December 8, 2004, approved the issuance of a demolition permit for the designated property known as 300 Maple Grove Road after the passing of a 180 day waiting period. The property was subsequently demolished in June, 2004.

**AND WHEREAS** Notice of Intention to Repeal By-law 93 – 98 and By-law 206 - 98 for the designated property known as 300 Maple Grove Road, Cambridge, Ontario, has been duly published and served;


**NOW THEREFORE BE IT RESOLVED THAT** The Corporation of the City of Cambridge enacts as follows:

1. THAT By-law 93 – 98 and By-law 206 - 98 are hereby repealed.
2. THAT the City of Cambridge is hereby authorized to cause a copy of this by-law to be served upon the owner of the said property and upon the Ontario Heritage Trust and to cause notice of this by-law to be published in a newspaper having general circulation in the City of Cambridge;
3. THAT it is Acknowledged and Directed that the office of the City Solicitor, or his/her designate, be authorized to register electronically any and all documents in connection with this transaction.

- 4. THAT this by-law shall come in to full force on the day it is passed.
