BY-LAW NO. 1667-86

A BY-LAW TO DESIGNATE THE QUEEN-PICTON STREET AREA OF NIAGARA-ON-THE-LAKE AS A HERITAGE CONSERVATION DISTRICT.

The Council of the Corporation of the Town of Niagara-on-the-Lake enacts as follows:

- 1. The area within the heavy lines shown on Schedule "A" attached hereto and forming part of this by-law, is hereby designated as a heritage conservation district under Part V of the Ontario Heritage Act, R.S.O. 1980, Chapter 337.
- 2. This By-law does not come into force without the approval of the Ontario Municipal Board.

READ A THIRD TIME AND PASSED THIS 23RD DAY OF JUNE, 1986.


