THE CORPORATION OF THE MUNICIPALITY OF PORT HOPE

BY-LAW NO. 16/2008

Being a By-law to create the John, Ontario and Queen Street Heritage Conservation District.

WHEREAS Part V of the Heritage Act, Subsection 41(1), empowers the Council of a municipality to designate the entire municipality or any defined area or areas of the municipality as a Heritage Conservation District;

AND WHEREAS Council issued a Request for Proposals in 2003, to study the possible expansion of the existing Walton Street Heritage Conservation District, primarily along John, Ontario and Queen Streets, adjacent to the existing WSHCD;

AND WHEREAS Following the report recommendation to expand the Heritage District, the John, Ontario and Queen Street Heritage Conservation District Plan was commissioned in March 2006, and has been prepared under the guidance of the Heritage Port Hope Advisory Committee in accordance with the requirements of the Heritage Act following adoption of Bill 60;

AND WHEREAS Council endorsed the final staff report regarding the proposed boundaries of the new John, Ontario and Queen Street Heritage Conservation District at their meeting on October 23, 2007;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF PORT HOPE ENACTS AS FOLLOWS:

- 1. THAT Council adopt the John, Ontario and Queen Street Heritage Conservation District Plan (as prepared by Nicholas Andrew Holman in association with the Heritage Port Hope Advisory Committee, dated January 2008) as the Conservation District Plan as required under Part V of the Heritage Act for this new Heritage Conservation District attached hereto forming part of this by-law as Appendix "A".
- 2. THAT the area identified on Appendix "B" attached hereto comprising part of this By-law is hereby designated and established as the John, Ontario and Queen Street Heritage Conservation District.
- 3. THAT this By-law shall come into force the day it is finally passed.

READ a FIRST, SECOND and THIRD time and finally passed in Open Council this 12th day of February, 2008.
