## BY-LAW NUMBER 116-2013

A BY-LAW TO AMEND BY-LAW NUMBER 22-2009 BEING A BY-LAW TO DESIGNATE THE SANDWICH HERITAGE CONSERVATION DISTRICT, AND ADOPT THE SANDWICH CONSERVATION DISTRICT PLAN.

Passed the 8<sup>th</sup>day of July, 2013.

WHEREAS the Council of The Corporation of the City of Windsor on January 26<sup>th</sup>, 2009 passed By-law 22-2009 pursuant to the provisions of s. 41(1) of the *Ontario Heritage Act*, R.S.O. 1990, c.0.18;

**AND WHEREAS** By-law Number 22-2009 as amended by OMB Decision PL090206 issued July 29, 2011 and Order issued October 19, 2012, was registered on the lands described in Schedule "A" attached thereto on December 14, 2012 as Instrument No CE548462 and on December 19 2012 as Instrument No. R1552188; attached hereto as Schedule "C".

**AND WHEREAS** Schedule "A" of By-law Number 22-2009 inadvertently omitted certain lands that were to be included in Schedule "A" attached thereto;

**AND WHEREAS** Schedule "A" of By-law Number 22-2009 included certain lands that should not have been included in Schedule "A" attached thereto;

**AND WHEREAS** it is deemed expedient to further amend said By-law Number 22-2009 of The Corporation of the City of Windsor by including the omitted lands and, by removing the By-law from the lands that should not have been included.

**NOW THEREFORE** the Council of the Corporation of the City of Windsor enacts as follows:

- 1. That By-law Number 22-2009 be amended as follows:
  - (1) That the lands described in Schedule "A" thereto be amended by **ADDING** the lands described in Schedule "A.1" attached hereto.
  - (2) That the lands described below be deleted from Schedule "A" thereto and that an Application **TO REMOVE** By-law 22-2009 be registered against the lands described as follows:
    - a) Part of Lot 10 E/S Sandwich Street abstracted as Bedford Street Plan 40 Town of Sandwich as in R1349851; Windsor 3329 Sandwich Street PIN 01253-0323 (LT)
    - b) Part of Lot 10 E/S Sandwich Street abstracted as Bedford Street Plan 40 Town of Sandwich as in R1297063; Windsor 3341 Sandwich Street PIN 01253-0321

2. That this by-law shall come into force and take effect on the day of the final passing thereof;

3. That this by-law be registered against the lands described in Schedule "A.1" attached hereto.
