### CORPORATION OF THE TOWN OF NEWMARKET

#### **BY-LAW NUMBER 2004-107**

A BY-LAW TO REPEAL BY-LAW 1991-27 BEING A BY-LAW TO DESIGNATE A PROPERTY AS BEING OF ARCHITECTURAL AND HISTORICAL VALUE OR INTEREST.

(Bonshaw House - west side of Yonge Street at 17850 Yonge Street)

WHEREAS the Bonshaw House formerly located at 17850 Yonge Street was designated pursuant to the provisions of the Ontario Heritage Act;

AND WHEREAS the Bonshaw House was relocated to 83 Dawson Manor Boulevard;

AND WHEREAS the property located at 17850 Yonge Street is no longer deemed to be of architectural or historical value and it is no longer appropriate to maintain the designation on the land;

AND WHEREAS Notice of Intention to Repeal the By-law was served on the Ontario Heritage Foundation and the owners of 17850 Yonge Street;

AND WHEREAS the Notice of Intention to Repeal the By-law was published in a newspaper having general circulation within the Town of Newmarket on May 11, 2004 and May 18, 2004;

AND WHEREAS no objection to the Notice of Intention to Repeal the By-law was received by the Town of Newmarket.

THEREFORE BE IT ENACTED by the Municipal Council of the Corporation of the Town of Newmarket as follows:

THAT By-law 1991-27 be hereby repealed. 1.
