interest under The Ontario Heritage Act.

A by-law of The Corporation of the City of Ottawa to repeal By-law Number 157-79.

WHEREAS the Council of the Corporation enacted By-law Number 157-79 entitled "A by-law of The Corporation of the City of Ottawa to designate **136 Bay Street** to be of historic or architectural value or interest" on the 6th day of June, 1979;


AND WHEREAS Section 34 of the Ontario Heritage Act, R.S.O. 1980, chapter 337, further authorizes the Council of a municipality to enact a by-law to repeal a by-law which designates property;

THEREFORE the Council of The Corporation of the City of Ottawa enacts as follows:

1. By-law Number 157-79 entitled "A by-law of The Corporation of the City of Ottawa to designate 136 Bay Street to be of historic or architectural value or interest" is hereby repealed.
2. The City Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper Land Registry Office.
3. The City Clerk is hereby authorized to cause a copy of this by-law to be served upon the owner of the property described in Schedule "A", and upon the Ontario Heritage Foundation, and to cause notice of this by-law to be published in a newspaper having a general circulation in the City of Ottawa.
4. The schedule attached hereto and marked Schedule "A" forms part of this by-law and all notations, references and other information contained therein shall be as much a part of this by-law as if all matters and information set forth in the said schedule were all fully described herein.

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the City of Ottawa, in the Regional Municipality of Ottawa-Carleton and Province of Ontario, and being composed of Lot Number Sixteen (16) on the North side of Queen Street, numbering westward, as shown and laid down on a Plan drawn by P. S. Slater, O.L.S. dated the 20th day of March, 1863 and registered in the Registry Office of Ottawa as number 3922.
