BY-LAW NUMBER 37-1975

A BY-LAW TO DESIGNATE THE EAST END FIRE HALL AS AN HISTORIC BUILDING.

WHEREAS the Council of the Corporation of the Town of Petrolia deems it advisable to designate the East End Fire Hall as an historic building;

 $\tt NOW\ THEREFORE$, the Municipal Council of the Corporation of Petrolia hereby enacts as follows:

- That, in recognition of the East End Fire Hall as the oldest brick structure in the East End of Petrolia and in the interest of preserving an excellent example of late 19th Century functional architecture, we designate the East End Fire Hall as an historic building under the provisions of the Ontario Heritage Act 1974.
- 2. And, that in order to ensure the dignity of the East End Fire Hall as a building of historical and architectural merit alterations on any part of the exterior are prohibited without the consent of Council.

THIS DECLARATION made PURSUANT TO Section 23 of the Registry Act, being Chapter 409 of the Revised Statutes of Ontario, 1970 and amendment thereto.

I, Paul J. Kilby to the Town of Petrolia in the County of Lambton do solemnly declare, that I am the solicitor for the Corporation of the Town of Petrolia, it being the municipality which passed the attached by-law and I do further declare that the attached by-law relates to the following lands:
