NOTICE OF INTENTION TO DESIGNATE

IN THE MATTER OF Section 29 of The Ontario Heritage Act, 1974.

AND IN THE MATTER OF an intention by The Corporation of the City of Burlington to designate property known as "OAKRIDGE", municipal number 2168 Guelph Line, part of Lot 16, Concession 1, S.D.S. in the City of Burlington, Regional Municipality of Halton.

NOTICE IS HEREBY GIVEN that the City of Burlington intends to designate the property known as "OAKRIDGE", municipal number 2168 Guelph Line, described in Registered Instrument No. 422494 in the Land Registry Office for the Registry Division of Halton (No. 20) (save and except the lands conveyed to The Regional Municipality of Halton for road widening purposes) in the name of Mrs. Lucie Marie Bush, to be of historic or architectural value or interest.

THE REASON FOR THE PROPOSED DESIGNATION is set out in Schedule "A" to this notice.

ANY PERSON INTERESTED MAY, within thirty (30) days after the date of first publication of this notice, serve on the Clerk of the City of Burlington a notice of objection setting out the reasons for the objection and all relevant facts.

ANY PERSON wishing to support the intention to designate may within thirty (30) days after the first date of publication of this notice, serve on the Clerk of The City of Burlington a notice of his support of the intention to designate together with a request for notice of any hearing that may be held giving also the name and address to which such notice should be sent.

SCHEDULE "A"

NOTICE OF INTENTION TO DESIGNATE REASONS FOR DESIGNATION

The exterior of this property is recommended for conservation as property having architectural and historical value or interest by the Local Architectural Conservation Advisory Committee of the City of Burlington and in the book entitled, "Head of the Lake" written by Dr. C.M. Johnston.

Built in Burlington in 1830-1850, the house is styled in the Georgian tradition. The house is of field stone, with the surface smoothed over to give the building a mortar-like effect. The two-storey rectangular plan has a Classical Revival six-panelled doorway, flanked on either side by sidelight transom and windows of evenly spaced proportions. A well-known architect, Arthur Wallace of Waterdown, described it as a 'Military type officer's quarters'. Two large stone chimneys, typical of the 1820-1830's rise at either end of the building.

After the war of 1812, Joseph Ireland, Overseer of Highways, was given a grant of land in East Flamborough. In 1820 he purchased the above property from Daniel O'Rielly who had been given the land by the Crown in 1808.

In 1823, Joseph married, and his son John, grandson, George and great granddaughter, Marie, the present owner, were born in this house.
