BY-LAW No. 909-2002

To amend City of Toronto By-law No. 413-2000 regarding the heritage designation of 2 Wellesley Place (Rupert Simpson House and Stable).

WHEREAS by By-law No. 413-2000, City Council designated the property at 2 Wellesley Place (Rupert Simpson House and Stable) as being of architectural and historical value or interest under Part IV of the *Ontario Heritage Act*; and

WHEREAS the legal description of the lands designated by By-law No. 413-2000 is attached to this by-law as Schedule "A";

WHEREAS the stable at the rear of the property has been assigned the municipal address 2R Wellesley Place, while the main house retains the address 2 Wellesley Place;

WHEREAS the owner of these lands has applied to change the boundaries of the lands designated by By-law No. 413-2000;

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1. By-law No. 413-2000 of the City of Toronto is amended by:
 - A. Deleting the words "2 Wellesley Place" from the title of the By-law and from section 1 and substituting "2 and 2R Wellesley Place" in their place.
 - B. Deleting the words "and shown on Schedule "C" " from section 1.
 - C. Deleting Schedule "B" attached to the By-law and replacing it with the following:

"SCHEDULE "B"

Part of PIN 21107-0041 (LT)

Part of Lot 44 on Plan D-30 designated as PARTS 18 and 24 on Plan 66R-19793 in the Land Titles Division of the Toronto Registry Office (No. 66) in the City of Toronto and Province of Ontario".
