BY-LAW NUMBER 10672

A BY-LAW TO DESIGNATE A BRICK BUILDING WITHIN THE CITY OF BELLEVILLE TO BE OF HISTORIC OR ARCHITECTURAL VALUE OR INTEREST (CITY HALL)

WHEREAS Section 29 of the Ontario Heritage Act, 1974 provides that where the Council of a Municipality has given notice of its intention to designate a property to be of historic or architectural value or interest and no notice of objection is served upon the said Municipality within the thirty (30) days of the date of the first publication of such notice of intention, the Council shall pass a by-law designating the property to be of historic or architectural value or interest;

AND WHEREAS all statutory requirements for giving notice of Council's intention to pass a by-law designating the property herein described to be of historic or architectural value or interest have been complied with;

AND WHEREAS no objection has been received to the by-law;

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF BELLEVILLE ENACTS AS FOLLOWS:

1. The brick building which has served as the City Hall for the City of Belleville since 1873, and which is located on Part of Lot 21 east of Front Street Government Plan and Part of Lot 5 according to Registered Plan No. 139 in the City of Belleville, which parcel of land is more particularly described in Schedule "A" attached hereto, be and the same is designated as a property of historic or architectural value or interest, as provided in the Ontario Heritage Act, 1974.

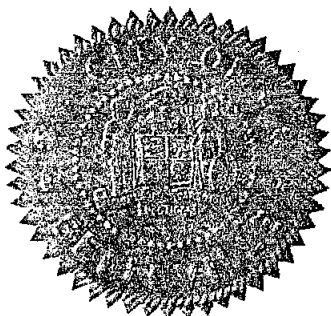
2. Nothing in this by-law shall be construed to designate any of the lands described in Schedule "A" attached hereto to be of historic or architectural value or interest, as provided in the Ontario Heritage Act, 1974.

THIS BY-LAW SHALL COME INTO FORCE AND TAKE EFFECT IMMEDIATELY ON AND AFTER THE PASSING THEREOF.

Read a first time this 10th day of September, 1979.

Read a second time this 10th day of September, 1979.

Read a third time and finally passed this 10th day of September, 1979.

SCHEDULE "A"

to BY-LAW NUMBER 10672

ALL AND SINGULAR that certain parcel or tract of land and premises, situate lying and being in the City of Belleville in the County of Hastings, being composed of the westerly 110 feet of even depth of Lot 21, east of Front Street, according to Government Plan duly registered and the westerly 110 feet of even depth of Lot 5 according to Registered Plan No. 139; save and excepting the public roadway known as McAnnany Street and the public roadway known as Market Street.
