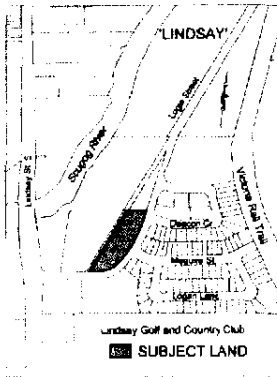

Description of the Heritage Attributes of the Property:

The home located at 41 Melbourne St. W in Lindsay is being recommended for designation on the basis of its architectural value. This building has several features that are worthy of designation including the turret located on the northeast elevation of the building, the decorative bargeboard trim at the peak of the gabled roof on the façade and the stained glass window on the north elevation of the home.

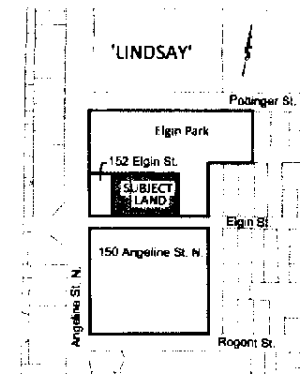
