**BY-LAW NO. 87- 70**

**of the**

**CORPORATION OF THE TOWN OF COLLINGWOOD**

Being a by-law to designate the properties known as:

1. 91 Hurontario Street
2. 83 Hurontario Street
3. 167 Pine Street

as properties of architectural and historic value or interest.

**WHEREAS** Section 29 of the Ontario Heritage Act, 1974, authorizes the Council of a municipality to enact by-laws to designate real properties including all buildings and structures thereon, to be of architectural or historical value or interest;

**AND WHEREAS** Notice of Intention to designate certain properties was served on the owners of the properties and on the Ontario Heritage Foundation on the \_\_\_\_\_ day of \_\_\_\_\_ 1987, and was published in the Enterprise-Bulletin on \_\_\_\_\_

**AND WHEREAS** no Notice of Objection to the proposed designations has been served on the Clerk of the Town of Collingwood;

**NOW THEREFORE** the Council of the Corporation of the Town of Collingwood enacts as follows:


1. There are designated as being of historical or architectural value or interest, the following properties in the Town of Collingwood:
  - a) 91 Hurontario Street
  - b) 83 Hurontario Street
  - c) 167 Pine Street


All as more particularly described in Schedule "A" attached hereto:

2. The Town Solicitor is hereby authorized to cause a copy of this By-law and the reasons for designation to be registered against the properties described in Schedule "A" hereto in the Land Registry Office at Barrie, Ontario.
3. The Clerk is hereby authorized to cause a copy of this By-law to be served on the owners of the properties described in Schedule "A" hereto and on the Ontario Heritage Foundation and to cause notice of the passing of this By-law to be published in the Enterprise-Bulletin once for each of three consecutive weeks.
4. This By-law shall come into force and take effect upon its final passing.

**THAT** this By-law. be introduced. read a first and second time and

THAT this By-law, having been considered in the Committee of the Whole, be presented, read a third time and finally passed this 14th day of December, 1987.
