## NOTICE OF INTENT TO REPEAL ASPECTS OF HERITAGE DESIGNATION BY-LAW

Take Notice that Norfolk County Council on December 17, 2019 initiated the process to amend aspects of Heritage Designation By-Law No. 62-87, Former Township of Delhi, respecting the property described as Lot E, Block 17, Plan 29B Vittoria in the former Township of Charlotteville (Vittoria Baptist Church 11 Lamport Street Vittoria).

In compliance with section 31(1) Ontario Heritage Act, R.S.O. 1990, c. O.18 Norfolk County is providing Public Notice of its intent to amend the By-Law through the repeal of the heritage designations upon the following features:

Omit the double doors and balustrade.

As required under Section 31(4)(c) of the Ontario Heritage Act, R.S.O. 1990, c. O.18 Norfolk County is required to provide the reason for repealing sections of the existing designation:

 The double doors and balustrade have been removed and/or altered in the course of renovations.

Pursuant to Section 31(4)(c) of the *Ontario Heritage Act, R.S.O. 1990, c. O.18* Anyone that wishes to file an objection to the proposed repealing of aspects of a Heritage Designation By-Law must serve on the Clerk of the municipality a notice of objection setting out the reason for the objection and all relevant facts within thirty days.

**TAKE NOTICE** that any objections to the repeal of aspects of the Heritage Designation By-Law are required to be submitted in person or through registered mail to the County Clerk at 50 Colborne Street, Simcoe Ontario N3Y 4H3 prior to 4:00 p.m. on **February**, **11 2020**.
