## **Notice of Decision – 193 Davy Street, Bath Heritage Permit**

Take notice that on December 9, 2019 the Council of Loyalist Township approved a heritage permit application to alter a designated property under Part IV, Section 33 of the Ontario Heritage Act for 193 Davy Street, Bath. The application was approved to seal openings in the exterior of the building, reattach and repair the soffit and fascia and install new eavestroughs, as outlined in the application with the following conditions:

1. That the heritage permit application for the Layer Cake Hall, 193 Davy Street, Bath be approved as a temporary measure to address the immediate needs of the building.
2. That the heritage permit application for the Layer Cake Hall, 193 Davy Street, Bath is conditional upon receiving approval from the Ontario Heritage Trust.
