
In the Matter of the Ontario Heritage Act and in the matter of the lands in the City of Burlington known municipally as 3083 Lakeshore Road, notice is hereby given that the City of Burlington intends to designate the above-noted property as being historically and culturally significant.

## **Notice of Intention to Designate: 3083 Lakeshore Road**

### ***Description of Property*** – Seaton House, 3083 Lakeshore Road:

3083 Lakeshore Road is a one and a half storey residential building, located east of Hart Avenue, on the north side of Lakeshore Road within the Roseland Community.

### ***Statement of Cultural Heritage Value or Interest:***

3083 Lakeshore Road's cultural heritage value lies in its architectural, contextual and historical significance. The heritage resources of interest are the grounds and the building, the context of 3083 Lakeshore Road and the history of ownership.

3083 Lakeshore is a one-and-a-half storey vernacular Arts and Crafts Cottage having attributes of the Craftsman style. These attributes include: the asymmetrical elevational design; the horizontal division between the lower and upper ½ storey; the stone, wood and stucco cladding; the roof bracketing and the massive fieldstone chimney through the front end gable. The attention to the roofline is also typical of the Craftsman style.

The context of 3083 Lakeshore Road is the Pine Cove Survey (1911), the Arts and Crafts Movement, the Garden City Movement, and Lakehurst Villa. There is an immediate architectural relationship between 3083 Lakeshore Road, the uncut rubble stonewall and gates of the Lakehurst Villa, and 3077 Lakeshore Road. The elongated six over three windows are nearly identical in proportion to the above noted properties. The siting of these houses is atypical of our time: the proximity to the sidewalk of the subject property and its counterpart at 3077 Lakeshore Road create a relationship with the street that newer houses on this stretch of Lakeshore Road lack.

The subject lands are of municipal historical significance for their association with the Waldie and Fisher families, and provincially so for the relationship to W.D. Flatt.
