THE CORPORATION OF THE TOWNSHIP OF CRAMAHE

BY-LAW NO. 90 - 18A

A BY-LAW TO DESIGNATE THE PROPERTY KNOWN MUNICIPALLY AS CASTLETON UNITED CHURCH, IN LOT 12, PLAN 57 (ORIGINAL TOWNSHIP LOT 34, CONCESSION 7) IN VILLAGE OF CASTLETON, IN THE TOWNSHIP OF CRAMAHE AS BEING ARCHITECTURAL AND/OR HISTORICAL VALUE OR INTEREST.

WHEREAS The Ontario Heritage Act, R.S.O. 1980 Chapter 337, authorized the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historical value or interest; and

WHEREAS the Council of the Corporation of the Township of Cramahe has caused to be served on the owners of the lands and premises at Castleton United Church, in Lot 12, Plan 57 (Original Township Lot 34, Concession 7) in Village of Castleton, in the Township of Cramahe and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks; and


WHEREAS no notice of objection to the proposed designation has been served on the clerk of the municipality;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF CRAMAHE HEREBY ENACTS AS FOLLOWS:


1. There is designated as beign of architectural and historical value or interest the real property known as: ALL AND SINGULAR that certain parcel or tract of land, in Lot 12, Plan 57 (Original Township Lot 34, Concession 7) in Village of Castleton, in the Township of Cramahe known as Castleton United Church.
2. The Clerk is hereby authorized to cause a copy of this by-law to be registered against the property described above in the proper land registry office.
3. The Clerk is hereby authorized to cause a copy of this By-law to be served on the owner of, the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this By-law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.

THIS BY-LAW SHALL COME INTO FORCE AND TAKE EFFECT ON THE FINAL READING THEREOF.
