NOTICE OF INTENTION TO DESIGNATE

Take Notice that the Council of the Corporation of the City of Brantford on the 20th day of September, 1993, decided to designate the lands and/or buildings known municipally as 85 William Street as a property of historical and/or architectural value or interest under The Ontario Heritage Act, 1990, R.S.O., Chapter 0.18, but that designation be limited to the exterior of the building.

SHORT STATEMENT OF THE REASONS FOR THE PROPOSED DESIGNATION

The property at 85 William Street is located on the east side of William Street between Palace Street and Richmond Street. It is occupied by a two-storey buff brick dwelling of Italianate design.

Two distinctive features of the front facade are the front gable end and the entrance porch. Of particular interest are the intricately decorative wooden fascia on the gable and a small round window trimmed with red brick just below the peak of the gable. A prominent feature of the north side facade is a gable section having a small half-round window near its peak.

The dwelling has a gable roof which is hipped at the front. Most of the windows are double hung units, having segmental heads and brick arched voussoirs.

The residence, constructed circa 1887, was first owned and occupied by George S. Winter, proprietor of G. S. Winter and Son, Grocers.

The building is a fine example of the Italianate style of residence built in Brantford in the late 19th century. Many of the architectural details are still in place and are in relatively good condition.

Notice of objection to the designation may be served on the City Clerk within thirty days of the 30th day of September, 1993.
