PUBLIC NOTICE

IN THE MATTER OF THE ONTARIO HERITAGE ACT, R.S.O. 1980, Chapter 337, Section 29

NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the Town of Caledon intends to designate the property at the following locations as properties of architectural and historical value or interest under Part IV of The Ontario Heritage Act, R.S.O. 1980, Chapter 337, Section 29.

- (1) Kidd-Williamson House
 Part West ½ Lot 38, Concession 1, Town of Caledon
 formerly Township of Albion
- / (2) Stinson-Courtney House
 Part West ½ Lot 31, Concession 2, Town of Caledon
 formerly Township of Albion
- √ (3) Boston Mills Cemetery
 Part East ½ Lot 33, Concession 3, W.H.S. Town of Caledon
 formerly Township of Chinguacousy

Reasons for Proposed Designations

- (1) <u>Kidd-Williamson House</u>
 This building was constructed in the 1850's for John Kidd, patriarch of the family which played an important role in the history of Mono Mills and surrounding area. A symmetrical, five-bay, limestone structure with central gable, it was used as an inn for a period during its history.
- (2) Stinson-Courtney House
 A symmetrical, five-bay, one and a half storey, limestone structure with small-pane windows, this building is a fine example of the vernacular Georgian and Neo-Classical styles, and was built in the 1850's for Edward Stinson.
- Boston Mills Cemetery
 Established in 1823, this is one of the oldest cemeteries in Caledon, and is still open to interments. The former Union Schoolhouse, S.S. #8
 Chinguacousy and S.S. #17 Caledon, is now used as a mortuary during the winter months. This limestone structure has a projecting frontispiece, and was constructed in 1888 by John Graham.

ANY PERSON may, within thirty days of the first publication of this notice, send by registered mail or deliver to the Clerk of the Town of Caledon notice of his or her objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts. When a Notice of Objection is received, the Council of the Corporation of the Town of Caledon shall refer the matter to the Conservation Review Board for a hearing and report.
