Please be advised that the Council of the Corporation of the Township of Selwyn intends to designate 2080 Chemong Road in the Smith Ward in accordance with the Ontario Heritage Act, R.S.O. 1990, c.0.18. ## Notice of the Intention to Designate Property Under the Ontario Heritage Act

Take Notice That the Council of the Township of Selwyn plans to pass a By-law on the 8th of March 2022, under Section 29(1) of the Ontario Heritage Act, for the property described as follows:

### **2080 Chemong Road (Smith Ward)**

2080 Chemong Road is a representative example of a stone farmhouse constructed in the Smith Ward in the mid-nineteenth century. The house was constructed in the early 1850s and is one of several similar stone farmhouses constructed in the rural area during this period. The home demonstrates a high degree of craftsmanship in the masonry finishes and in its use of both local granite and limestone. The home has historical and associative value in its association with Alexander Scott, an early settler in the former Smith Township, and with William Telford, a local stone mason.
