## Public Notice in the matter of the Ontario Heritage Act, R.S.O. 1990 Chapter O.18, Section 29 | Notice of intention to designate former St. Alban's Anglican Church

Take notice that the Council for The Corporation of the Town of Caledon intends to designate the property at the following location as being of cultural heritage value and interest under Part IV of the Ontario Heritage Act, R.S.O. 1990, Chapter O.18, Section 29.

The property known municipally as 17219 Highway 50 contains an 1882, brick church building formerly known as St. Alban's Anglican. The church site is a landmark on the main street of Palgrave. The building is typical of a rural, English Gothic Revival style church structure built in the 19th century for smaller parishes throughout Ontario. St. Alban's retains most of its original design features. Further information regarding the heritage attributes and designation of this property is available in the Heritage Resource Office at the Town of Caledon Town Hall.

Any person may, within thirty days of the publication of this notice, send by registered mail or deliver to the Clerk notice of his or her objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts. If a notice of objection is received, the Council for The Corporation of the Town of Caledon will refer the matter to the Conservation Review Board for a hearing and report.
