NOTICE OF INTENTION TO DESIGNATE UNDER THE ONTARIO HERITAGE ACT

IN THE MATTER OF THE ONTARIO HERITAGE ACT AND IN THE MATTER OF the lands in the Town of Halton Hills known municipally as 55 Mill Street, East, legally described as "PT 11 21, BLK4, PL 31, ALSO SHOWN ON PL 1098; PT LT 22, BLK4, PL 31, AS IN 835185 ALSO SHOWN ON PL 1098; "TW 242792" HALTON HILLS' AMENDED MAR 9'99 & OCT 13/9 J. MENARD' SUBJECT TO AN EASEMENT IN GROSS OVER PT 2 20R19598 AS IN HR1160481", Regional Municipality of Halton, and known as Sunderland Villa. NOTICE IS HEREBY GIVEN that the Town of Halton Hills intends to designate the property at 55 Mill Street, East, Acton, under Section 29(1), Part IV of the Ontario Heritage Act, RS.O. 1990, Chapter O18.

Statement of Cultural Heritage Value or Interest:

The property at 55 Mill Street East has historical and associative value due to its associations with William Heslop Storey, a notable figure in the mid-to-late-nineteenth century in Acton with significant ties to the community. Storey established the Canada Glove Works on Bower Avenue, employing hundreds of local individuals and was known throughout Canada. Storey was instrumental in the incorporation of the village of Acton in 1873 and served as Acton's first Reeve. He also served as a councillor for 18 years and was Warden of Halton County, Justice of the Peace, chairperson of the school board, director of several insurance companies, president of the Canadian Manufacturer's Association, and long-standing member of the Methodist church.
