THE CORPORATION OF THE TOWN OF GANANOQUE

BY-LAW NO. 79 - 3

WHEREAS THE ONTARIO HERITAGE ACT, 1974 provides that the Council of a municipality, if it desires to designate a property to be of historic or architectural value or interest shall pass a by-law so designating the property.

NOW THEREFORE, the Council of The Corporation of the Town of Gananoque enacts as follows:-

1. The building owned by Rulaman Development Corporation known as The Old Foundry, located upon Lot 1027A, Block N, East of the Gananoque River according to Plan 86 of the Town is hereby designated a property of historic and architectural value or interest.
