

## NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the Town of Gananoque intends to designate the property, including land and building, at the following municipal address as a property of architectural and historical value under Part IV of the Ontario Heritage Act, R.S.O. 1990, C. O.18.

St. John's Church, located on Stone Street South, Lots 637 and 638, Plan 86 East of the Gananoque River, Town of Gananoque

Reasons for the proposed designation:

Erected in 1890 in a dramatic Romanesque mode, St. John's Church is a fine example of the work of Joseph Connolly, one of Canada's finest 19<sup>th</sup> century ecclesiastical architects. Notable features of the church are the great rose window; the stonework combining intricately carved elements and rubbed work with rock faced ashlar; and particularly the dichromatic slate roof patterned as a vast mosaic. Perched prominently above the Gananoque River, St. John's Church is an important visual feature of Gananoque's architectural heritage.

Any person may, within thirty days of the publication of this notice, send by registered mail or deliver to the Clerk of the Town of Gananoque notice of his or her objection to the proposed designation together with a statement of the reasons for the objection and all relevant facts. If such a Notice of Objection is received, the Council of the Corporation of the Town of Gananoque shall refer the matter to the Conservation Review Board for a hearing.
