**Notice of Withdrawal of a Notice of Intention to Designate  
the following property to be of Cultural Heritage Value and Interest Pursuant to  
the Provisions of the *Ontario Heritage Act* (R.S.O. 1990, Chapter 0.18)**

**Take Notice** that the Council of The Corporation of the City of Kingston at their meeting of February 4, 2025 has withdrawn its intention to pass a by-law under Section 29 of the *Ontario Heritage Act*, R.S.O. 1990, Chapter 0.18, to designate the following lands to be of cultural heritage value and interest:

**262 Wellington Street** (Part Lot E, Original Survey, Kingston City, as in FR352614, except the easement therein; City of Kingston, County of Frontenac); and

**4226 Florida Road** (Part Lot 13-14, Con 7, Western Addition, Kingston, Part 3, 13R18702, Except Parts 1 & 2, 13R18793; City of Kingston, County of Frontenac), known as the Walker Farmstead;
