NOTICE OF WATERMAIN FLUSHING – BEETON
Residential / Industrial / Commercial Users

Please be advised that the Town of New Tecumseth Public Works Department will be conducting routine maintenance/flushing of the **Beeton** Distribution System daily between the hours of **8:00am** and **4:00pm** commencing **September 17, 2018**. This process may take up to **three (3)** weeks to complete. Anticipated date of completion is **October 5, 2018**.

During the flushing process, low water pressure and discoloured water may be experienced. It is recommended cold water taps are checked and let run until water runs clear (usually five to ten minutes). If discolouration persists for longer please contact the Public Works Department. It is also suggested that before starting laundry, fill and run the washing machine through a rinse cycle to prevent staining of laundry items.

PUBLIC NOTICE
IN THE MATTER OF THE ONTARIO HERITAGE ACT, R.S.O. 1990, CHAPTER O.18, SECTION 29 NOTICE OF INTENTION TO DESIGNATE COLGAN HOUSE

TAKE NOTICE that the Council for the Corporation of the Town of New Tecumseth intends to designate the front façade and the south exterior wall at the following location as being of cultural heritage value and interest under Part IV of the Ontario Heritage Act, R.S.O 1990, Chapter O.18 Section 29:

The property known municipally as 2157 Adjala-Tecumseth Townline is a 19th century brick clad Victorian farmhouse known as the Colgan House for its association with local poet John C. Colgan (1811-1879). The crossroad hamlet where he lived was named for Colgan after his death in 1879.

The property's significant features include: the south exterior wall which shows evidence of the home's evolution over time, the setback and viewshed from the road, the front façade, gently arched windows, corbelled chimneys, gabled roofline, and the raised brick details at the roof peaks. Further information regarding the heritage attributes and designation of this property is available at the Town of New Tecumseth Administration Building in Alliston.

Any person may, within thirty days of the publication of this notice, send by registered mail or deliver to the Clerk notice of his or her objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts. If a notice of objection is received, the Council for the Corporation of the Town of New Tecumseth will refer the matter to the Conservation Review Board for a hearing and report.
