384-388 George Street North

384-388 George Street North's cultural heritage value lies in its importance place as continuation of the historic commercial row. It shares similar Italianate-style design features with other buildings of a similar era, creating a cohesive landscape. Past tenants of note include Jospheh Pentland, was one Peterborough's early dentists, confectioner James Long, and John McClelland, watchmaker and sometime town councillor.
