**THE CORPORATION OF THE TOWN OF WASAGA BEACH**

**BY-LAW NO. 2026-02**

Being a By-law to repeal By-law No. 2007-60 Designating Beck Square as a property of cultural heritage value and interest

**WHEREAS** the Council of the Town of Wasaga Beach enacted By-law 2007-60 which designated the property municipally known as 84 Mosley Street and commonly known as "Beck Square", as a property to be of cultural heritage value or interest;

**AND WHEREAS** the designation of the Property was made pursuant to the Ontario Heritage Act, R.S.O. 1990, c. 0.18, as amended;

**AND WHEREAS** Section 31 of the *Ontario Heritage Act*, R.S.O. 1990, c. 0.18, as amended, provides for the repeal of a designating by-law;

**AND WHEREAS** the Clerk provided notice of the intent to repeal the heritage designation for Beck Square, in accordance with the Act and no objections were received within the 30-day period;

**AND WHEREAS** Council has considered the continued appropriateness of the designation and now deems it advisable to repeal By-law 2007-60;

**NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF WASAGA BEACH HEREBY ENACTS AS FOLLOWS:**

1. **THAT** By-law 2007-60, being a by-law to designate the lands municipally known as 84 Mosley Street and commonly known as "Beck Square", and as described in Schedule "A" attached hereto as a property of cultural heritage value or interest, is hereby repealed in its entirety.
2. **THAT** the designation of the property as a property of cultural heritage value or interest is hereby removed, and the property shall no longer be subject to the provisions of By-law 2007-60.
3. **THAT** the Clerk is hereby authorized to update the municipal records accordingly and provide notice of the repeal to such persons, agencies or boards as may be required.
4. **THAT** a copy of this By-law be registered on title at the Land Registry Office.
5. **THAT** this By-law shall come into force and effect in accordance with the applicable provisions of the Ontario Heritage Act.
