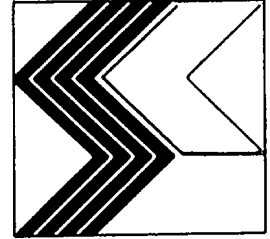



NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE THAT the Council of The Corporation of the City of St. Catharines on the 12th day of August 1991, resolved its intention to designate as property of historic or architectural value or interest, under the terms of the Ontario Heritage Act, R.S.O. 1980, Chapter 337, the lands and buildings described as follows:
