## NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the Town of Haldimand intends to designate the property, including lands and buildings, at the following municipal address as a property of historical value or interest under Part IV of the Ontario Heritage Act, 1980, S.O. Chapter 337.

(a) The Gore School, S.S. #7, Concession 2, Part Lot 24, in the Town of Haldimand in the Regional Municipality of Haldimand Norfolk, in the Province of Ontario, formerly in the Township of Oneida.

## Reasons for proposed Designation

- (1) Acquired by grant from Indian Land Sale, 1860.
- (2) This present brick school was constructed in 1882. Scholars were instructed there until 1960.
- (3) The architecture is typical of local schools built at that time and it is the only Oneida one room school in its original state and of use to the public.

Notice of objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts may be served on the Clerk of the Town of Haldimand before the Twenty-Second day of November 1984.
