**THE CORPORATION OF THE TOWN OF GODERICH
BY-LAW NO.83 OF 1998**

A by-law to de-designate a property of architectural and/or historical significance as a Heritage property.

WHEREAS By-law No. 50 of 1981 designates certain property under Part 4 of the Ontario Heritage Act.

AND WHEREAS an application has been made by the trustees of Victoria Street Church to de-designate this property.

AND WHEREAS the Ontario Heritage Act, R.S.O. 1990, Chapter 0.18, Section 32, the Municipality, upon application and after consultation with the Local Advisory Committee, may consent and pass a by-law repealing a by-law, or part thereof, designating properties.

AND WHEREAS the original intent was a voluntary basis.

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE TOWN OF GODERICH ENACTS AS FOLLOWS:

1. That Schedule "A" and specifically Designation 2. Described as "The Victoria Street United Church", 40 Victoria Street South, more specifically known as Plan 457, Lot 127, be hereby deleted from the register as a Heritage Designated property pursuant to Part 4 of the Act.

Reason for Designation:

1. "The Victoria Street United Church". The Victoria Street United Church has been referred for historical designation for architectural reasons. It is a rectangular building in plan, having two opposing gable dormers around the altar. Its construction is of natural stone foundation progressing to a light coloured brick bearing walls. The main façade, using complex proportions and roof slope, gives the rectangular building an apparent asymmetrical plan. This three- plan façade and sides are rich in corbelling (decorative brickwork). Brick surrounds cap the tall pointed arch windows. Also, there are full circular surrounds about delicate circular vents that are situated at each of the four axes. The original wooden doors form an important part of the front design, enframed in a gothic archway.
