THE CORPORATION OF THE CITY OF WOODSTOCK 5451 -78

A by-law to amend By-law Number 5309-77 of The Corporation of the City of Woodstock.

BY-LAW NUMBER

WHEREAS By-law Number 5309-77 designated the property municipally known as 210 Vansittart Avenue of historical value.

AND WHEREAS the owner of the property has requested and applied to the Council of the municipality to repeal part of By-law 5309-77.

AND WHEREAS the Council has sought and received consultation from its local Advisory Committee.

AND WHEREAS the Council has consented to pass a by-law repealing part of By-law 5309-77.

NOW THEREFORE the Council of The Corporation of the City of Woodstock enacts as follows:

- Schedule "A" to By-law 5309-77 is hereby deleted and Schedule 1 _ "A" to this by-law is substituted in its place.
- That a new section 4 shall be added to and form part of 2. By-law 5309-77:
 - This designation shall not apply to any interior area or part of the existing residence and shall apply only to the exterior facades of the existing residence.
- That a copy of this by-law shall be registered against the property described in Schedule "A" hereto in the proper Land Registry Office.
- That the Clerk is hereby authorized to cause a copy of this by-law to be served upon the owner of the aforesaid property and upon the Ontario Heritage Foundation, and to cause notice of this by-law to be published in a newspaper having general circulation in the City of Woodstock.

READ a first and second time this 13 day of JUL, READ a third time and finally enacted this /3 day of Vac 7, 1978.

forming part of By-law Number 5451-78

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the City of Woodstock, in the County of Oxford and Province of Ontario and being composed of Part of Park Lot 3 in the First Range North of Ingersoll Avenue, according to Registered Plan 10, and designated as PART 1 on a Reference Plan deposited in the Registry Office for the Registry Division of the County of Oxford as Number 41R-1930.
