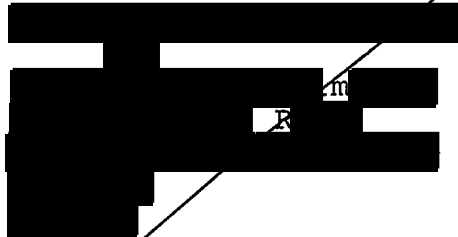

NOTICE OF DECISION

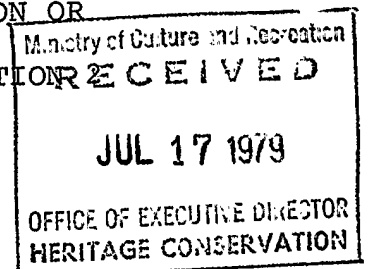


Take notice that the Council of the Corporation of the City of Toronto, on the 25th day of June, 1979, having considered the application for Consent to Demolish the buildings erected on the property known municipally as No. 73 Gormley Avenue, and after giving consideration to the matter, decided:

- (A) TO REFUSE THE APPLICATION TO DEMOLISH UNDER SECTION 34 OF THE ONTARIO HERITAGE ACT, 1974 AND PROHIBIT ANY WORK TO DEMOLISH OR REMOVE ANY BUILDING OR STRUCTURE ON THE PROPERTY KNOWN MUNICIPALLY AS NO. 73 GORMLEY AVENUE FOR A PERIOD OF ONE HUNDRED AND EIGHTY (180) DAYS FROM THE 25TH DAY OF JUNE, 1979; AND
- (B) TO RECOMMEND THAT THE EXECUTIVE COMMITTEE BE REQUESTED TO GIVE CONSIDERATION TO THE MATTER OF EXPROPRIATION OR PURCHASE OF SAID PROPERTY UNDER SECTION 36, SUBSECTION OF THE ONTARIO HERITAGE ACT, 1974; AND



(C) TO RECOMMEND THAT THE EXECUTIVE COMMITTEE ALSO BE REQUESTED TO GIVE CONSIDERATION TO AN ANNUAL BUDGET ITEM OF \$500,000. FOR THE PURCHASE OF HISTORICALLY DESIGNATED BUILDINGS.
