## THE CORPORATION OF THE TOWN OF HALTON HILLS

### BY-LAW NO. 77-94

A by-law to designate the former Acton Town Hall as an historical site.

WHEREAS the Council deems that the former Acton Town Hall to be of historic value and interest;

AND WHEREAS the Council considers that this property and building should be preserved due to its significance as an early centre of local government;

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE TOWN OF HALTON HILLS ENACTS AS FOLLOWS:

1. That the former Acton Town Hall on Willow Street be and the same is hereby designated an historical building and property.

2. That the subject property is more particularly described on Schedule "A" attached hereto and forming part of this by-law.

#### DESCRIPTION OF LAND

### OLD TOWN HALL SITE - ACTON

ALL AND SINGULAR that certain parcel or tract of land and premises, situate lying and being in the Town of Halton Hills in the Regional Municipality of Halton in the Province of Ontario being composed of Part of Lot J according to a subdivision of Lot 37 in Block 3 in Registered Plan 31 formerly in the Town of Acton now in the Town of Halton Hills and which said parcel or tract of land and premises is more particularly described as 'follows:-

PREMISING the line of Willow Street has a bearing of North 45 degrees 15 minutes West and relating all bearings herein thereto;

COMMENCING at the Westerly angle of Lot J;

THENCE North 37 degrees 44 minutes East along the Northwesterly limit of Lot J being also the Southeasterly limit of Bower Street 95.8 feet to the Northerly angle of Lot J;

THENCE South 52 degrees 58 minutes East along the Northeasterly limit of Lot J a distance of 100.0 feet;

THENCE South 37 degrees 44 minutes West 109.33 feet more or less to the Southwesterly limit of Block J;

THENCE North 45 degrees 15 minutes West along the Southwesterly limit of Lot J being also the Northeasterly limit of Willow Street 100.74 feet more or less to the point of commencement.
