TOWNSHIP OF CENTRE WELLINGTON

BY-LAW NO. 2006-011

Being a By-law to designate 19 George Street in the former Township of Nichol (Salem), to be of Cultural Heritage Value or Interest

WHEREAS on the advice of the Cultural Heritage Committee, Council has been advised to designate the property noted below to be of cultural heritage value or interest to the provisions of the *Ontario Heritage Act*, R.S.O. 1990, c.O.18;

AND WHEREAS the provisions of Section 29, Subsections (1), (2), (3) and (4) have been complied with and no objection has been received by the Municipality.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF CENTRE WELLINGTON HEREBY ENACTS AS FOLLOWS:

- The lands and premises described 19 George Street, Nichol Concession 11, Part Lot 15, RP61R6504, Parts 1 & 2, Salem, (Formerly in Township of Nichol), now in Township of Centre Wellington are hereby designated to be a building of cultural heritage value or interest.
- The reasons for the designation are as follows:

Cultural Heritage Value or Interest:

Built in 1880 by Sem Wissler and used as a store and post office. This single detached two storey dwelling with rectangular short façade is constructed of coursed limestone rubble with cut quoins and has a medium gable roof. Recommendation for designation based on historical significance to the village.

Heritage Attributes to be protected:

Exterior walls constructed of coarse limestone rubble. Cut quoins tooled and hammered. Decorative tie rods.

- This By-law shall be registered against the title of the lands described as 19 George Street, Nichol Concession 11, Part Lot 15, RP61R6504, Parts 1 & 2, Salem, (Formerly in Township of Nichol), now in Township of Centre Wellington
- This By-law shall come into force and take effect upon its final passing.
