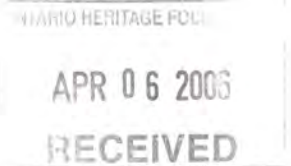

TOWNSHIP OF CENTRE WELLINGTON

BY-LAW NO. 2006-016

Being a By-law to designate 22 David Street West
in the former Village of Elora,
to be of cultural heritage value or interest

WHEREAS on the advice of the Municipal Heritage Committee, Council has been advised to designate the property noted below to be of cultural heritage value or interest under the provisions of the *Ontario Heritage Act*, R.S.O. 1990, c.O.18;

AND WHEREAS the provisions of Section 29, Subsections (1), (2), (3) and (4) have been complied with and no objection has been received by the Municipality.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF CENTRE WELLINGTON HEREBY ENACTS AS FOLLOWS:

1. The lands and premises described as 22 David Street West, Plan 112, Lot 23, N/S David Street, (Formerly in Village of Elora), now in Township of Centre Wellington are hereby designated to be a building of cultural heritage value or interest.
2. The reasons for the designation are as follows:

Cultural Heritage Value or Interest:


Built in 1874, this Ontario Cottage style single detached dwelling was built by William and Elizabeth Gray who were the owners of a lime kiln which was on the property and so named Kiln Cottage. This building features a rectangular short façade, lime grout walls, with centre gable, side chimneys left and right, a centre façade main entrance, two original sash windows 6/6, and a low gable roof with a centre gable with pointed style window.


Heritage Attributes to be protected:

Exterior walls made of lime grout from Kiln.
Centre gable with pointed window.
Side chimneys left and right.
Centre façade main entrance with transom.
Two front original sash windows 6/6.


3. This By-law shall be registered against the title of the lands described as 22 David Street West, Plan 112, Lot 23, N/S David Street, (Formerly in Village of Elora), now in Township of Centre Wellington
4. This By-law shall come into force and take effect upon its final passing.


