TOWNSHIP OF CENTRE WELLINGTON

BY-LAW NO. 2006-23

Being a By-law to designate 275 Hill Street West in the former Town of Fergus, to be of cultural heritage value or interest

WHEREAS on the advice of the Municipal Heritage Committee, Council has been advised to designate the property noted below to be of cultural heritage value or interest to the provisions of the *Ontario Heritage Act*, R.S.O. 1990, c.O.18;

AND WHEREAS the provisions of Section 29, Subsections (1), (2), (3) and (4) have been complied with and no objection has been received by the Municipality.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF CENTRE WELLINGTON HEREBY ENACTS AS FOLLOWS:

- The lands and premises described as 275 Hill Street West, Plan 55, Lot F11, N/S Hill Street, (Formerly Town of Fergus), now in Township of Centre Wellington are hereby designated to be a building of cultural heritage value or interest.
- The reasons for the designation are as follows:

Cultural Heritage Value or Interest:

Built in 1875, this 1 ½ storey single detached dwelling has a rectangular plan long façade and is constructed of red stretcher brick with a centre gable.

Heritage Attributes to be protected:

All exterior brick walls.

All 2/2 windows.

Front centre gable.

Right side original single brick chimney.

- This By-law shall be registered against the title of the lands described as 275
 Hill Street West, Plan 55, Lot F11, N/S Hill Street, (Formerly Town of Fergus),
 now in Township of Centre Wellington
- 4. This By-law shall come into force and take effect upon its final passing.
