### TOWNSHIP OF CENTRE WELLINGTON

#### BY-LAW NO. 2006-027

Being a By-law to designate 445 Tower Street South in the former Town of Fergus, to be of cultural heritage value or interest

WHEREAS on the advice of the Municipal Heritage Committee, Council has been advised to designate the property noted below to be of cultural heritage value or interest to the provisions of the *Ontario Heritage Act*, R.S.O. 1990, c.O.18;

**AND WHEREAS** the provisions of Section 29, Subsections (1), (2), (3) and (4) have been complied with and no objection has been received by the Municipality.

# NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF CENTRE WELLINGTON HEREBY ENACTS AS FOLLOWS:

- The lands and premises described as 445 Tower Street South, Plan 77, Part Lot 48, Part Lot 49, W/S Tower Street, (Formerly Town of Fergus), now in Township of Centre Wellington are hereby designated to be a building of cultural heritage value or interest.
- 2. The reasons for the designation are as follows:

### Cultural Heritage Value or Interest:

This 1  $\frac{1}{2}$  storey single detached dwelling was constructed in 1863 and features a rectangular long facade, with stucco walls, 6/6 front windows, a centre entrance and gable.

## Heritage Attributes to be protected:

All exterior walls.

Two front 6/6 main floor windows.

- This By-law shall be registered against the title of the lands described as 445
  Tower Street South, Plan 77, Part Lot 48, Part Lot 49, W/S Tower Street,
  (Formerly Town of Fergus), now in Township of Centre Wellington
- This By-law shall come into force and take effect upon its final passing.
