TAKE NOTICE that the Council of the Corporation of the City of Sault Ste. Marie intends to designate the properties at the following municipal addresses as properties of cultural heritage value and interest under Part IV of The Ontario Heritage Act, R.S.O. 1990, chapter O.18.

REASONS FOR PROPOSED DESIGNATION (1) ROTARY WELCOME CAIRNS - RUSS RAMSAY WAY

It is recommended that the structures known as the Rotary Welcome Cairns situated at the head of Russ Ramsay Way be designated as having cultural heritage value and interest under the Ontario Heritage Act Part IV because they are a significant landmark and remain as a historical reference to the City's original industrialized waterfront. Built in 1938 as the international gateway to the City, these cairns were constructed of red sandstone and served to welcome people coming off the ferry.

REASONS FOR PROPOSED DESIGNATION (2) SAULT STE. MARIE CENOTAPH - 426 Queen Street East

It is recommended that the structure known as the Sault Ste. Marie Cenotaph situated at 426 Queen Street East be designated as having cultural heritage value and interest under the Ontario Heritage Act Part IV because it is an excellent example of memorials erected across Canada to honour those who died in World War I. This memorial was designed by Alfred Howell and consists of the main statue and two bronze side panels on the upper level and a plaque recognizing Victoria Cross winner William Merrifield five steps below and directly in front. The memorial bears an inscription composed specifically for it by Rudyard Kipling.
