Take notice that the Council of the Corporation of the City of Toronto has passed By-law No. 1997-0298 to repeal By-law No. 566-79 which designated the property known municipally as 121 Avenue Road.

No. 1997-0298. A BY-LAW

To repeal By-law No. 566-79, being "A By-law To designate the Property at No. 121 Avenue Road, of architectural value".

(Passed June 23, 1997.)

WHEREAS Council, at its meeting of June 25, 1979, passed By-law No. 566-79, designating the property at 121 Avenue Road under the *Ontario Heritage Act* as being of architectural value or interest;

AND WHEREAS the historic building on the property was destroyed by fire and subsequently demolished in 1995;

AND WHEREAS the present owner has now made an application under Section 32 of the *Ontario Heritage Act* requesting that City Council consent to the repeal of By-law No. 566-79;

AND WHEREAS City Council, at its meeting of June 23, 1997, adopted Clause 11 of the Neighbourhoods Committee Report No. 9, recommending that By-law No. 566-79 be repealed;

THEREFORE the Council of The Corporation of the City of Toronto enacts as follows:

- 1. By-law No. 566-79, being "A By-law To designate the Property at No. 121 Avenue Road, of architectural value" is repealed.
- 2. The City Solicitor is hereby authorized to cause a copy of this By-law to be registered against the property described in Schedule "A" to this by-law in the proper land registry office.
- 3. The City Clerk is hereby authorized to cause a copy of this By-law to be served upon the owner of the property and upon the Ontario Heritage Foundation and to cause notice of this By-law to be published in a newspaper having general circulation in the City of Toronto as required by the *Ontario Heritage Act*.
