No. 620-86. A BY-LAW

To repeal By-law No. 68-86 respecting the designation of the Property at No. 1947 Bloor Street West.

(Passed September 8, 1986.)

The Council of The Corporation of the City of Toronto enacts as follows:

- 1. By-law No. 68-86, being "A By-law To designate the Property at No. 1947 Bloor Street West, of architectural value and of historic interest.", is hereby repealed.
- 2. The City Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper land registry office.
- 3. The City Clerk is hereby authorized to cause a copy of this by-law to be served upon the owner of the aforesaid property and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in a newspaper having general circulation in the City of Toronto and to cause the reference to the property to be deleted from the Register referred to in subsection 27(1) of the Ontario Heritage Act, R.S.O. 1980, Chapter 337.

SCHEDULE "A"

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the City of Toronto, in the Municipality of Metropolitan Toronto and Province of Ontario, being composed of Lot 343 on Plan M-438 registered in the Land Registry Office for the Land Titles Division of Metropolitan Toronto (No. 66).

The southerly limit of Bloor Street West as confirmed under the Boundaries Act by Plan BA-1954, registered on September 28, 1981, as Plan D-755. (see A-949748).

Being the Secondly described lands in Parcel 2-1 in the Register for Section M-435.

SCHEDULE "B"

Reasons for the designation of the Property at No. 1947 Bloor Street West (Joy Oil Gas Station).

The Joy Oil Gas Station at 1947 Bloor Street West is designated on architectural and historical grounds. It was built in the late 1930's as one of a chain of Joy Oil Company Limited gas stations. The firm, which had stations in both Toronto and Detroit was originally the Hercules Oil Company, and was owned by Mrs. Herbert Austin. There were fourteen such gas stations within the City of Toronto, of which six remain intact. Designed in the Chateau style, the station is architecturally distinctive for its diminutive scale, steeply sloping roof with flared eaves, turretted office and its leaded fenestration. It established a recognizable corporate image for the gas company at a time when the use of the automobile was increasing rapidly, and has remained a local neighbourhood landmark.
