**THE CORPORATION OF THE TOWN OF MILTON**

**BY-LAW NO. 036 - 2008**

**BEING A BY-LAW TO AMEND BY-LAW NO. 40-90, A BY-LAW TO DESIGNATE THE PROPERTY KNOWN MUNICIPALLY AS THE EXTERIOR OF THE HOUSE ONLY, PART OF LOT 21, CONCESSION 5, NAS, AS IN 843022 (PIN 24986-0114 (LT) MILTON/NASSAGAWEYA, AS BEING OF ARCHITECTURAL VALUE OR INTEREST**

**WHEREAS** Part IV of The Ontario Heritage Act, R.S.O. 1990, Chapter O. 18, as amended, authorizes the Council of a municipality to enact a by-law to designate real property, including all buildings and structures thereon, to be of cultural heritage value or interest;

**AND WHEREAS** By-law No. 40-90 was approved by Council on July 9, 1990, which by-law designated twelve properties located at the Part of Lot 21, Concession 5, NAS, as in 843022, Milton/Nassagaweya, as having architectural value or interest;

**AND WHEREAS** 4271 20 Side Road (which has the legal description set out in paragraph 1 below) is the only property that should have been designated as having architectural value or interest by By-law No. 40-90;

**AND WHEREAS** notice was provided to the affected property owners on 20 Side Road and Fifth Line to inform them that By-law No. 40-90 is being amended;

**AND WHEREAS** since no objections have been received regarding the amendment of By-law No 40-90, Council is desirous of amending the legal description of By-law No. 40-90 to ensure that only 4271 20 Side Road is designated as having architectural value or interest.

**NOW THEREFORE** the Council of the Corporation of the Town of Milton hereby enacts as follows:


1. **THAT** the legal description as set out in Schedule "A" to By-law No. 40-90 be amended to read:


ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Town of Milton, Regional Municipality of Halton more particularly described as Part of Lot 21, Concession 5, NAS, as in 843022 being PIN 24986-0114(LT).

2. **THAT** this amending By-law be registered against all the properties against which By-law No. 40-90 was registered more particularly set out in Schedule "A" attached hereto.
3. **THAT** all other provisions of By-law No. 40-90 remain in force and effect.

4. THAT this By-law shall come into force and effect on the day it is passed.

READ a FIRST, SECOND and THIRD TIME and FINALLY PASSED this 28th day of April, 2008.
