


**TAKE NOTICE THAT** the Council of the Corporation of the Town of Milton intends to designate the building known municipally as 360 Pine Street, (Survey Teetzel, Blk 11, Pt. Lot 10) in the Town of Milton, Regional Municipality of Halton, in the Province of Ontario, as being of historical and architectural value or interest under Part IV of The Ontario Heritage Act, R.S.O. 1990, c.O. 18.

**REASONS FOR THE PROPOSED DESIGNATION:**

John S. Hatton bought the land from Mathias Teetzel in 1854 and built this house in 1855. The house is a two-storey brick house with three bays, stone foundation and a three flue chimney. The low hip roof has projecting eaves, moulded wood fascia, soffit and frieze. The windows are flat with voussoirs, wood sashes, plain lug sills, double-hung. The house has a central doorway with multiple light transom, sidelights, single leaf with six panels, voussoir and the porch is a stone platform with metal railings.
