TAKE NOTICE THAT the Council of the Corporation of the City of Windsor intends to designate the properties, including lands and buildings, at the following municipal addresses, as properties of architectural and/or historical value or interest under Part IV of The Ontario Heritage Act:

**350 DEVONSHIRE ROAD**

**(the former Walkerville Town Hall (a.k.a. Barclay Building)) - only the 'footprint' of the building to be**

**designated.**

**REASONS FOR DESIGNATION:**

- Built in 1904 to serve as the Walkerville Town Hall and Post Office.
- Designated by the internationally recognized architectural firm of Albert Kahn Associates.
- Moved from its original site on Riverside Drive East in 1995 to a location on Devonshire Road, as originally intended.
- Served as a train station for several years after Willstead Manor became the municipal offices building from 1921 to 1935.
- Currently owned by the Preserve Walkerville chapter of the Architectural Conservancy of Ontario.

**721 Walker Road (Part Lots 2 and 4, Block S, Plan 211)**

**REASONS FOR DESIGNATION:**

- Example of Victorian-era middle-class housing built in Walkerville in 1893, and an integral component of the architectural group of houses on the west side of Walker Road, 700 block, known as "Walker's Road Heritage Block;"
- Stretcher-bond brick cladding with segmental arch structural openings, trimmed with brick voussoirs;
- Double-hung multi-paned wood sash windows;
- Wooden architectural details including millwork, porch details, louvred attic vents and gable fascia boards with finial.

Any person may, within thirty days of the first publication of this notice, send by registered mail or deliver to the Clerk of the City of Windsor notice of his or her objection to the proposed designations together with a statement of the reasons for the objection and all relevant facts. If such a Notice of Objection is received, the Council of the Corporation of the City of Windsor shall refer the matter to the Conservation Review Board for a hearing.
