BY-LAW NO. 76-90

Being a By-law to amend Schedule 'A' of By-law No. 44-84, being a By-law to designate the property known municipally as 5576 Highway 25, as being of architectural and historical value or interest.

WHEREAS Section 32 of The Ontario Heritage Act, R.S.O. 1980, as amended, provides that the Council of a Municipality may, by By-law, repeal a portion of a By-law designating a property as being of architectural or historical value or interest;

AND WHEREAS the Regional Municipality of Halton has made application to Milton Council to repeal a portion of By-law No. 44-84, being a By-law to designate the property known municipally as 5576 Highway 25, as being of architectural and historical value or interest, as it affects only Part 13 on Plan 20R-9465;

AND WHEREAS the Milton Local Architectural Conservation Advisory Committee has consented to the application;

AND WHEREAS the Council of The Corporation of the Town of Milton desires to amend By-law No. 44-84, to delete Part 13 on Plan 20R-9465 from the description outlined in Schedule "A" to By-law No. 44-84;

NOW THEREFORE THE COUNCIL FOR THE CORPORATION OF THE TOWN OF MILTON ENACTS AS FOLLOWS:

- 1. THAT Schedule 'A' to By-law No. 44-84 is hereby amended by the addition of the description as described in Schedule "A" to By-law No. 76-90, attached hereto, so that Part 13 on Plan 20R-9465 is no longer designated under The Ontario Heritage Act as being of architectural and historical value or interest.
- 2. AND THAT the Municipal Solicitor is hereby authorized to cause a copy of this By-law to be registered against the property described in Schedule "A", hereto, in the proper Land Registry Office.
- 3. AND THAT the Clerk is hereby authorized to cause a copy of this By-law to be served on the Owner of the aforesaid property and on The Ontario Heritage Foundation and to cause Notice of the Passing of this By-law to be published in the same newspaper having general circulation in the municipality once for each of three (3) consecutive weeks.
- 4. AND FURTHER THAT all other provisions of By-law No. 44-84, as amended, shall remain in full force and effect.

READ a FIRST, SECOND and THIRD TIME and FINALLY PASSED this 17th day of December, 1990
