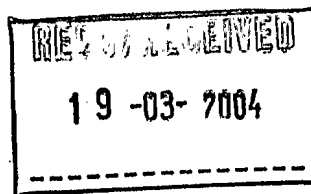

BY-LAW NO. 04-18

A BY-LAW TO REPEAL BY-LAW NO. 92-18, BEING  
A BY-LAW TO DESIGNATE THE PROPERTY  
KNOWN MUNICIPALLY AS THE MOYER HOUSE,  
3443 RITTENHOUSE ROAD, VINELAND, PLAN M-2,  
PART LOT 227, R.P. 30R-2469, PART 2, IN THE  
TOWN OF LINCOLN

WHEREAS the Council of the Corporation of the Town of Lincoln did, on the 16<sup>th</sup> day of March, 1992, enact By-law 92-18, being by-law to designate the property known municipally as the Moyer House, 3443 Rittenhouse Road, Vineland, Plan M-2, Part Lot 227, R.P. 30R-2469, Part 2, as being a structure of architectural or historical value or interest.

AND WHEREAS the Council of the Corporation of the Town of Lincoln now deems it expedient to repeal the said By-law 92-18;

AND WHEREAS notice of the intention of the Council to repeal the said By-law 92-18 has been served in accordance with the requirements of the Ontario Heritage Act, R.S.O. 1990, c.O.18, as amended;

AND WHEREAS the Council has consulted with the Town of Lincoln Local Architectural Conservation Advisory Committee regarding the matter;

AND WHEREAS no Notice of Objection to the repeal of the said By-law 92-18 has been served on the Clerk of the Town of Lincoln in accordance with the said Ontario Heritage Act;

NOW THEREFORE, THE COUNCIL OF THE CORPORATION OF THE TOWN OF LINCOLN ENACTS AS FOLLOWS:

1. That By-law No. 92-18, being by-law to designate the property known municipally as the Moyer House, 3443 Rittenhouse Road, Vineland, Plan M-2, Part Lot 227, R.P. 30R-2469, Part 2, as being a structure of architectural or historical value or interest, passed by the Corporation of the Town of Lincoln on the 16<sup>th</sup> day of March, 1992, is hereby repealed.

BY-LAW read a FIRST time this 15<sup>th</sup> day of March, 2004.

BY-LAW read a SECOND time this 15<sup>th</sup> day of March, 2004.

BY-LAW read a THIRD time and FINALLY PASSED this 15<sup>th</sup> day of March, 2004.
